City of Richmond: If the sale price is \$999,001.00, it will be rounded up to \$1,000,000.00. The applicable tax rate is \$12.50 per thousand dollars. 2. City of Berkeley: For properties sold over \$1.6 million, such as a sale price of \$1,600,500.00, the amount is rounded up to \$1,700,000.00. The tax rate is \$25.00 per thousand dollars. Please ensure that you are aware of these calculations to avoid any discrepancies. For more detailed information, visit the city's official website or contact the city's tax department.
